NH BioBlitz

How would you like to spend a fun hour or two outdoors walking on one of your town-owned conservation properties while helping with an important species identification project developed by the UNH Cooperative Extension? The UNH "BioBlitz" project description is below and, as indicated, you do not need to be an expert!

Your EK Conservation Commission members felt this would be a great opportunity for us to get together with you, provide a quick onsite training on using the iNaturalist (free app), and tour two of our conservation properties while recording data. The dates are to be determined, but will be in September – when it's cooler, and directions will be provided. If you have any interest, we'd love to hear from you: send us a quick note, subject "BioBlitz" at EKconservation@gmail.com.

What is the NH BioBlitz?

A BioBlitz is a species scavenger hunt where volunteers help find and record data on as many different wild living things as possible in a certain area and a short amount of time. During the month of September 2021, we need your help finding and documenting species (plants, animals, insects, fungi) found on town-owned lands all over New Hampshire using iNaturalist. This is a statewide event and you can participate on town-owned lands right in your own community!

Why should I participate in the 2021 NH BioBlitz?

The Statewide 2021 NH BioBlitz is a fun way to get outside and record biodiversity on town-owned lands all over the state. You don't need to be an expert to participate - iNaturalist can help you identify the species of plants, insects, fungi, and wildlife that you find! You'll learn more about the world around you and will help your town

- learn more about the natural resources in your community.
- 1. Download the iNaturalist app on your phone/tablet (or access iNaturalist through your computer) and create an account.
- 2. Become a member of the NH BioBlitz project to keep track of observations made by you and others.

Our Natural Resources Inventory is Underway!

An East Kingston Natural Resources Inventory is underway!

The purpose of this report is to serve as a planning tool for the town to protect our natural features and preserve the rural nature of East Kingston.

The East Kingston Conservation Commission (EKCC) and three townspeople are working to identify and inventory the town's:

- $\cdot \ important, \ naturally \ occurring \ resources, \ such \ as \ forests, \ farmlands, \ streams, \ lakes \ and \ wetlands$
- · cultural resources (historic, scenic, and recreational assets)
- · wildlife, habitats and wildlife corridors
- $\cdot \ unfragmented \ habitat \ blocks$
- · conservation lands

Natural resources provide a variety of environmental, health, economic, recreation, and public safety benefits:

- 1. improve air and water quality
- 2. support wildlife and fish habitat
- 3. enhance property values
- 4. provide spaces for people to recreate or simply interact with nature
- 5. minimize flood damage

An early finding of our work is that nearly one-half (45%) of East Kingston is Appalachian-Oak-Pine Forest habitat.
